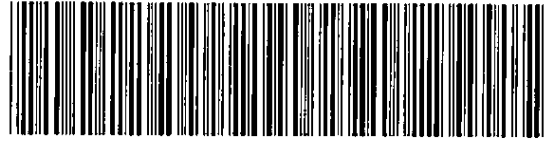

1. They are the current Managing Member and Secretary of CREATIVE LIFE, LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on January 27, 2005.

2. The following Amendment to the Articles of Organization was unanimously adopted by the Members at a special meeting at which all of the Members were present and voting throughout, duly called for the purpose of adopting this Amendment and held on October 25, 2017.

3. There are 100,000 membership units authorized, and 1,000 membership units issued and outstanding. All of said issued and outstanding membership units are entitled to vote, and all of the
