The latest date on which the Limited Liability Company is to dissolve is January 31, 2055.

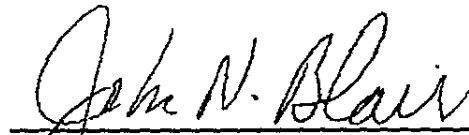
ARTICLE VI - LIABILITY OF MEMBERS
