

Articles of Organization Of West Coast Feed, LLC

ARTICLE I. NAME

The name of the limited liability company shall be West Coast Feed, LLC (the "Company").

ARTICLE II. PURPOSE

The company shall have unlimited power to engage in and do any lawful act concerning any or all lawful businesses for which limited liability companies may be organized according to the laws of the State of Florida, including all powers and purposes now and hereafter permitted by law to a limited liability company.
