# ARTICLES OF ORGANIZATION

### ARTICLE 1 - NAME

The name of the limited liability company shall be **POLYMER TECHNOLOGIES OF S.W. FL., LLC**, ("Company").

### ARTICLE 2 - ADDRESS

### ARTICLE 3 - EFFECTIVE DATE




