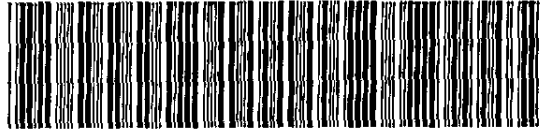


ARTICLE VII


