ARTICLES OF ORGANIZATION
FOR

The undersigned (the "Members") being all of the Members of ZMG STRATFORD, LLC, hereby execute and adopt the following Amended and Restated Articles of Organization pursuant to Chapter 608, Section 608.411, Fla. Stat. under the Florida Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on January 28, 2005:

**ARTICLE I
NAME**

The name of the limited liability company is ZMG STRATFORD, LLC.
