
**ARTICLE VI

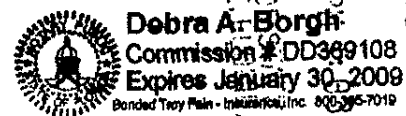


