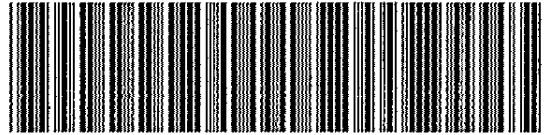

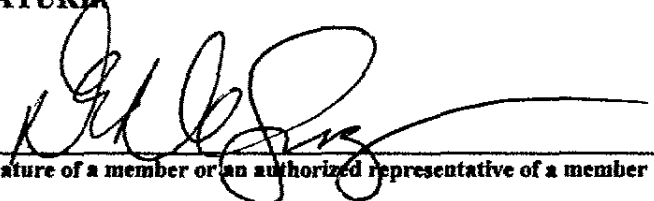
the continued existence of the Company as may be authorized by Florida Statutes.
