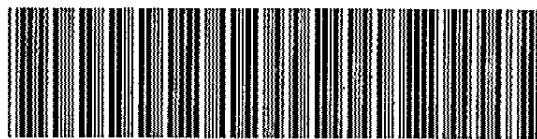

ARTICLE V – LIMITED LIABILITY OF MEMBER

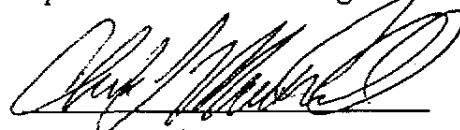
No Member of the Company shall be liable for the debts, liabilities, or obligations of the Company in excess of the amount of the Member's investment.

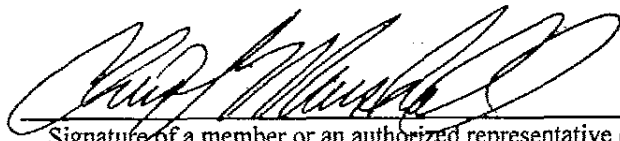
