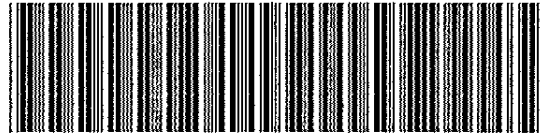

Transferability of Member's Interest

An Interest of a Member in this Company may be transferred or assigned only to such extent and in the manner provided in the regulations and Operating Agreement.

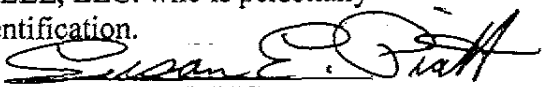

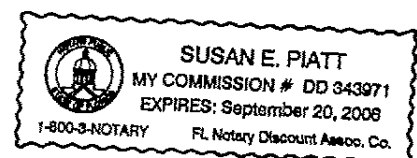
