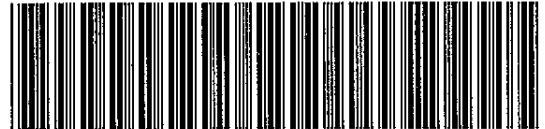

## **ARTICLES OF ORGANIZATION**

To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans and other incentive plans for any or all of the members and employees of the company, and for any or all of the members and employees of any subsidiary of the company.

To be a promoter, incorporator, general partner, limited partner, member, associate, or manager of any corporation, partnership, limited partnership, joint venture, trust or other enterprise.

To transact any and all lawful business for which companies may be organized under the laws of the State of Florida.

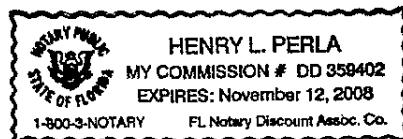


