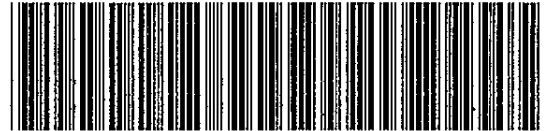

ARTICLES OF ORGANIZATION
OF

The undersigned, desiring to form a limited liability company under the Florida Limited Liability Company Act, Section 608.40 - 608.514, Florida Statutes, does hereby make, acknowledge and file these Articles of Organization.

Article I
Name

Initial Registered Office and Agent

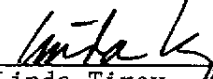

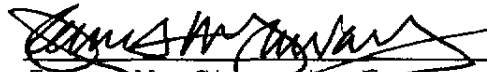
