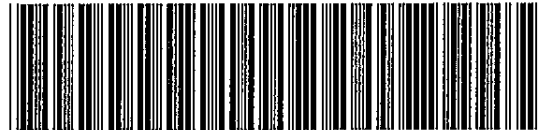


8. **Right to Continue Business:**

9. **Capital and Members:**

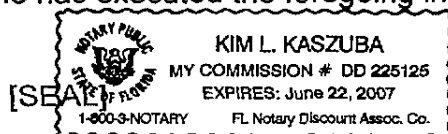


