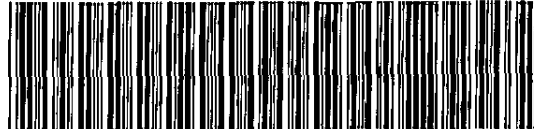


**ARTICLE V.


