
FIRST: The Articles of Organization were filed on January 25, 2005 and assigned document number L05000010790.

SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:

The purpose of business and business model is to provide:

1. Purchasing / procurement services and consulting. Supply management consulting.
2. Vendor contract solicitation, review and recommendation.
3. Wholesale purchasing of items and retail sales.
4. Remodeling consultant - coordinating planning, budgeting and solicitation of quotations for the home owner from qualified suppliers and licensed tradesman.
