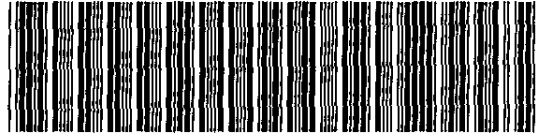

ARTICLE I: NAME

The name of this limited company is ACUVOTE, LLC, whose address is 2425 Andros Lane, Fort Lauderdale, Florida 33312. *This is also the mailing address*

ARTICLE II: DURATION

This limited company shall have perpetual existence.

ARTICLE III: PURPOSE

performance of my duties, and I am familiar with and accepts the obligations of my position as registered agent as provided for in Chapter 608, F.S.

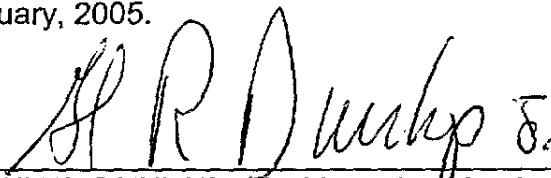
