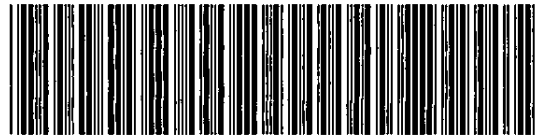



unanimously authorized by the Company's managers and members.


ARTICLE III - OTHER MATTERS






