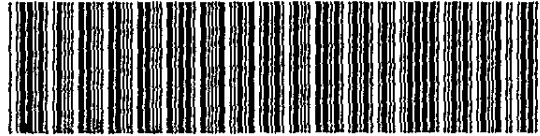



ARTICLES OF ORGANIZATION
JSM, LLC
A LIMITED LIABILITY COMPANY

1. **Name.** The name of the limited liability company is JSM, LLC.
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the State of Florida.
3. **Address of Principle Office.** The address (mailing and street address) of the principal office of the limited liability company is 1220 E. Livingston Street, Orlando, FL 32803.
4. **Term.** Term of this LLC shall be perpetual.
5. **Members at Time of Formation.** There will be at least one member at the time the limited liability company is formed.
6. **Period of Duration.** The period of duration shall be perpetual.
7. **Management.** Management of the Limited Liability Company at the time of formation shall be by manger(s) whose name(s) and address(es) are as follows:




