

ARTICLES OF ORGANIZATION

OF

Manufactured Home Store, L.L.C.

A Florida Limited Liability Company

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, subscribe, acknowledge and file these Articles of Organization.

ARTICLE I

The name of the corporation shall be the Manufactured Home Store, L.L.C.

ARTICLE II

The mailing address and street address of the principal office of the company is 109 Marbled Godwit Ct., Daytona Beach, FL 32119.

ARTICLE III

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV

The name and street address of the registered agent of the company in the State of Florida are: Robert Lee McClary, 109 Marbled Godwit Ct., Daytona Beach, FL 32119.

ARTICLE V

The members of the company shall contribute to the capital of the company. Members shall not be personally liable for the debts, obligations or liabilities of the company except and unless specifically assumed in writing by the member. The initial members of the company shall be Robert Lee McClary and Todd A. Patrick.

ARTICLE VI

Exception as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member all of the members of the company other than the member proposing to dispose of his or her interest, approval of the proposed transfer by written consent.

ARTICLE VII

The purpose for which this company is organized is to engage in any or all lawful acts or activities in which limited liability companies may engage under the Florida Limited Liability Company Act or under the laws of any other jurisdictions in which this company may transact business. This company shall be authorized to conduct and transact any business and engage in any activity that is lawfully authorized, including and not limited to, to invest the funds of this limited liability company in real estate, mortgages, stocks, bonds, and other investments, and to own real and personal property as necessary and proper for the furtherance of the purposes of this company; and to do any act necessary or incidental to the protection and benefit of this company.

ARTICLE VIII

The company shall be dissolved on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by majority vote of all the remaining members.

ARTICLE IX

The company shall be managed by the members in accordance with regulations


ARTICLE X
