### RJF VENTURES, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

#### 1. Name.

The name of the limited liability company is RJF VENTURES, LLC (hereinaster referred to as the "LLC").

#### 2. Effective Date.

The date of the commencement of the LLC existence shall be the date of the filing of these Articles with the Secretary of State.

#### 3. <u>Period of Duration</u>.
