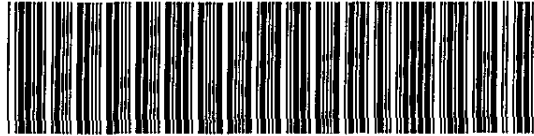

**ARTICLES OF ORGANIZATION
OF

WE, the organizers hereto, do hereby execute these Articles of Organization of CMHF Urban Investments L.L.C., a limited liability company, organized under and pursuant to the provisions of Chapter 608, Florida Statutes.

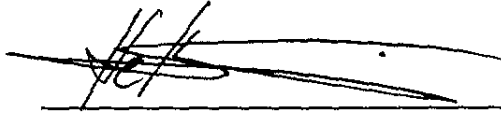

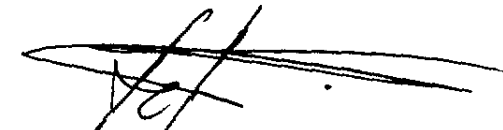
