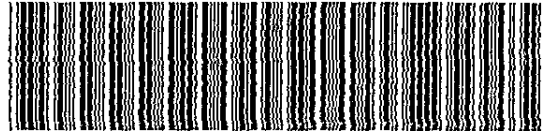



ARTICLES OF ORGANIZATION
FOR
JETSTREAM GROUND SERVICES OF ATLANTA, LLC
a Florida Limited Liability Company

ARTICLE I – Name

The name of the limited liability company (hereinafter “Company”) is:

ARTICLE II – Address


