

ARTICLES OF ORGANIZATION OF

FIVE E ASSOCIATES, LLC

These Articles of Organization of Five E Associates, LLC (the "Company"), have been duly executed and are being filed by the undesigned member to form a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608) as follows:

ARTICLE I
