

**ARTICLE I
Name**

ARTICLE VI
Registered Agent and Registered Office

ARTICLE VII
Restrictions on Membership

The operating agreement shall be repealed or altered only by the members of the Limited Liability Company, in the manner prescribed by the laws of the State of Florida.


