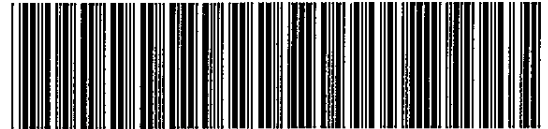

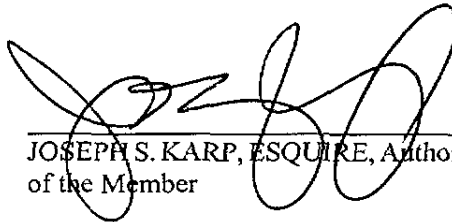
MANAGEMENT

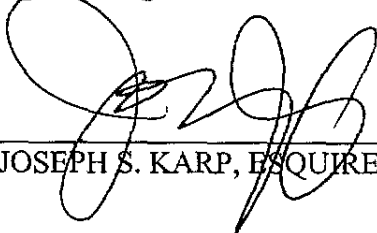
