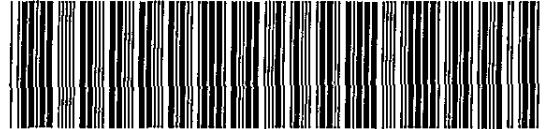

MANAGEMENT**


