**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
AQUAPLEX REALTY, LLC**

The undersigned, acting as an authorized representative of a member of Aquaplex Realty, LLC, a Florida limited liability company (the "Company"), whose Articles of Organization were originally filed with the Florida Department of State effective as of February 4, 2005, adopts the following Amended and Restated Articles of Organization of the Company:

**ARTICLE I

The principal office and mailing address of the Company is 4313 Harbor Watch Lane, Lutz, Florida 33558.


**ARTICLE III
