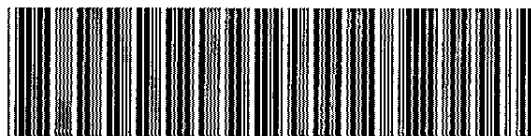

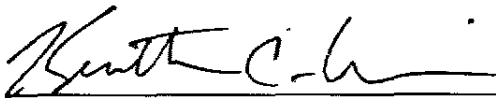
**ARTICLE 5

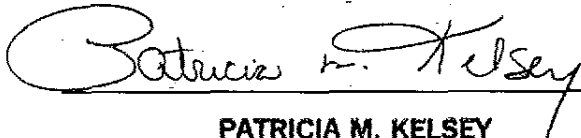

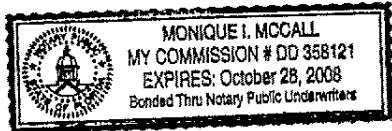


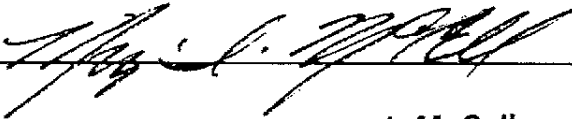
