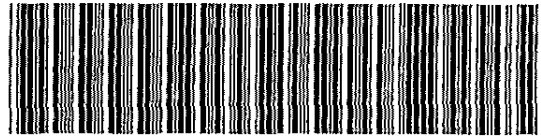

**ARTICLES OF ORGANIZATION**

The undersigned, William J. 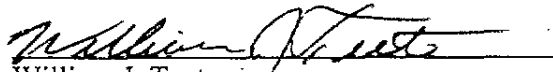
**ARTICLE V -- COMPANY TO BE MANAGED BY MEMBER(S)**

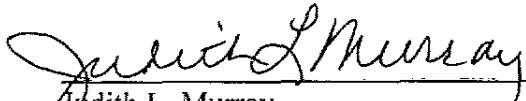

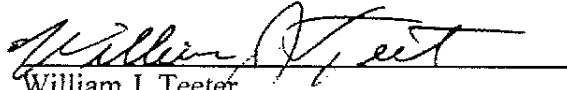
