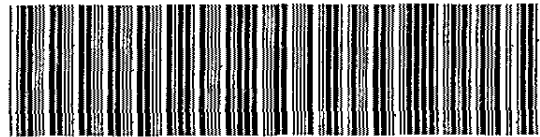

ARTICLES OF ORGANIZATION
OF
CMB FINANCIAL MANAGEMENT, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **CMB FINANCIAL MANAGEMENT, L.L.C.**

ARTICLE II - ADDRESS

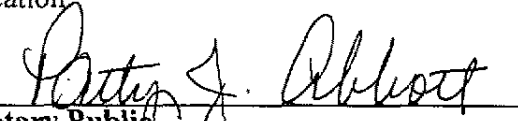
