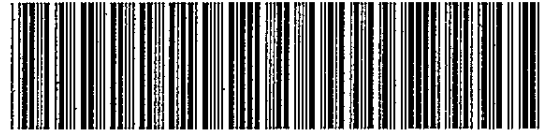

ARTICLES OF ORGANIZATION

OF

CMB FINANCIAL, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **CMB FINANCIAL, L.L.C.**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 755 Hillcrest Drive NW, Bradenton, Florida 34209.

ARTICLE III - DURATION

THE PERIOD OF DURATION for this Limited Liability Company shall be until (i) the death, retirement, resignation and/or dissolution of a member of the Limited Liability Company; (ii) the occurrence of any other event that terminates the continued membership of a member in the Limited Liability Company; (iii) the Limited Liability Company is dissolved in a manner provided by law; or (iv) as further provided in the regulations of the Limited Liability Company as adopted by the members. 
