ARTICLES OF ORGANIZATION

OF

JW CONSTRUCTION SERVICES, L.L.C.

The undersigned members to these Articles of Organization, persons competent to contract, hereby form a limited liability company, under Chapter 608, Florida Statutes, and do hereby certify that it has become such company under and pursuant to the following Articles of Organization.

ARTICLE I Name

The name of the limited liability company is "JW CONSTRUCTION SERVICES, L.L.C."

ARTICLE II Duration

The company shall have perpetual existence commencing on the date of filing.

ARTICLE III Appointment and Acknowledgment of Designated Registered Agent and Office Address

The name and street address of this company in itial registered agent is Jason William Melton, 152 Highway 73 Marianna, Florida 32448.
