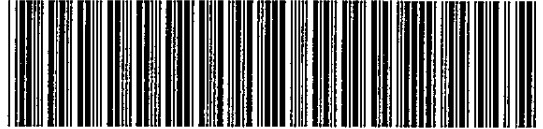



2. Principal Place of Business.




