ARTICLES OF ORGANIZATION

OF

TITAN LAKE WHIPPOORWILL, LLC a Florida limited liability company

The undersigned, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

ARTICLE ONE - NAME

The name of the limited liability company shall be TITAN LAKE WHIPPOORWILL, LLC (the "Company").

ARTICLE TWO - COMMENCEMENT OF EXISTENCE

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
