



Additional members may be admitted by the members in accordance with the Operating Agreement of the Company and the members shall determine the amount and the nature of contributions by new members.


**ARTICLE VII

AMENDING REGULATIONS**

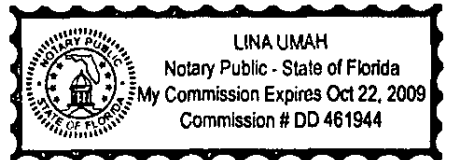
The power to adopt, alter, amend or repeal the Operating Agreement of the Company is vested entirely in the members.

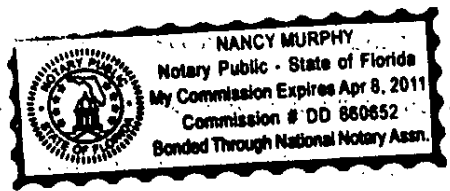


