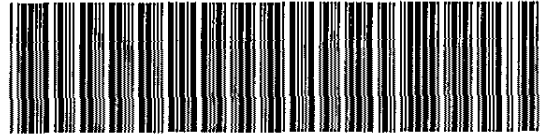

ARTICLE I - Name

The name of the limited liability company is **ENVIRONMENTAL & COMPLIANCE SERVICES, L.L.C.**

ARTICLE II - Address

The profits and losses of the limited liability company shall be allocated among the members equally except as may be set forth in the regulation and/or a separate document signed by all members.

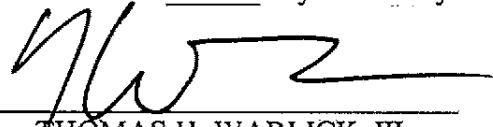
ARTICLE VIII - Admission of Additional Members

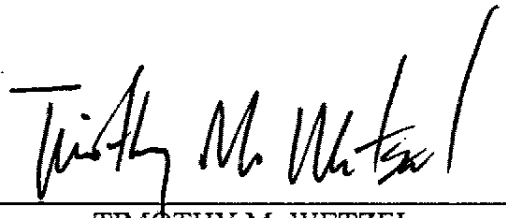
ARTICLE IX - Members' Rights to Continue Business
