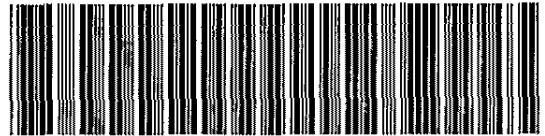

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is JOEY37, LLC

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 11400 SW 3<sup>rd</sup> Street, Plantation, Florida 33325.

Article III. Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of Clearwater at 2201 NE Coachman Road, Suite 102, Clearwater, Florida 33765. The initial registered agent is Rick W. Sadorf, whose business address is the same as the post office address of the initial registered office, and who is a resident of Florida and a member of the Florida State Bar.



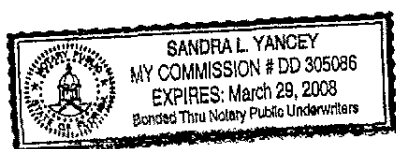


