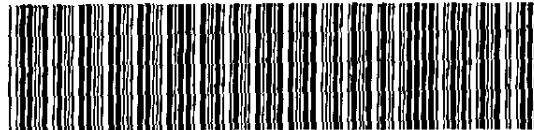


ARTICLES OF ORGANIZATION
