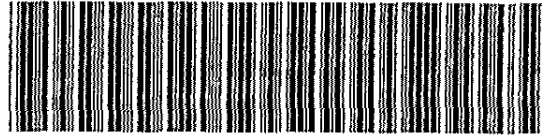



**ARTICLE I: NAME**

The name of this limited liability company shall be DLM Lead Gen Systems, LLC (the "Company").

This Company shall be a manager-managed limited liability company. Accordingly, this Company shall be managed by one or more managers subject to the provisions set forth in the




