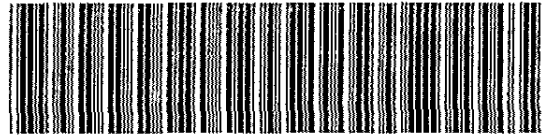

ARTICLE V: PURPOSE AND POWERS




