

#### ARTICLE I.

### PREAMBLE: FORMATION

The undersigned, KEVIN C. SCHLEICHER and JUDY MONROE, do hereby form a Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, titled as the "Florida Limited Liability Company Act," as hereinafter set forth.

## ARTICLE II.

# NAME; PLACE OF BUSINESS; AND REGISTERED AGENT

#### DELEGATION OF MANAGEMENT
