ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Elorida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME
