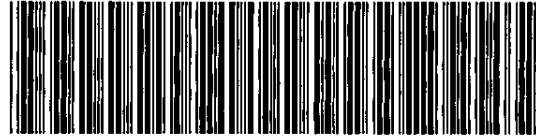

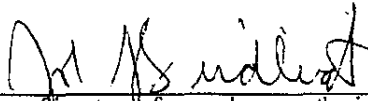

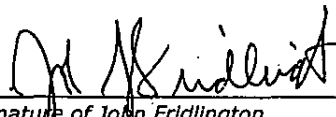
**ARTICLE 3
