FIRST: The Articles of Organization were filed on February 11, 2005 and assigned document number L05000014710.

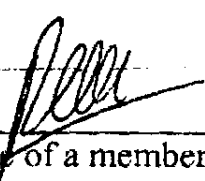

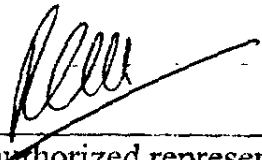
