ARTICLES OF ORGANIZATION FOR HJN GLOBAL INVESTMENTS, L.L.C.

ARTICLE I - Name:

The name of the Limited Liability Company is: HJN GLOBAL INVESTMENTS, L.L.C.

- 7. They shall be regarded as independent purposes and powers.

ARTICLE IV: Profit & Losses:
