ARTICLE V. MANAGEMENT OF COMPANY


The business of the Company shall be managed by its Sole Member, and shall not be a Manager-Managed Company.

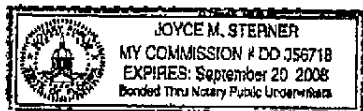
