**ARTICLES OF ORGANIZATION
OF

The undersigned, acting as an authorized representative of the initial member of the above captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of this limited liability company is TIMELESS TREASURES BOOK SHOPPE, LLC (the "Company"), and its principal office and mailing address is 216 North Parsons Avenue, Brandon, Florida 33510.

**ARTICLE II
EFFECTIVE DATE**

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State.

**ARTICLE III
PURPOSE OF ORGANIZATION**

The Company is organized for the purpose of operating a book store that supplements and supports the Christian education programs and ministry of its sole member and offers gifts, tapes, music videos, multi-media items and publications for sale to the public for the benefit of the member and the community that it serves. INITIAL REGISTERED OFFICE AND AGENT


**CERTIFICATE DESIGNATING
