INDEMNIFICATION

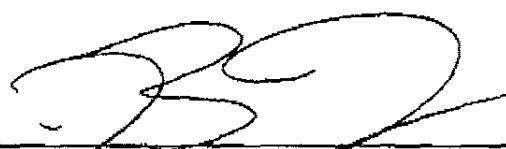
