

### ARTICLES OF ORGANIZATION OF

#### J.D. ALTOM DRYWALL, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be J.D. ALTOM DRYWALL, L.L.C..

#### ARTICLE II -- ADDRESS

The mailing address of the principal office is P.O. Box 607, Ft. McCoy, FL 32134 and the street address of the principal office is 116 Finley Lane, Ft. McCoy, FL 32134.

#### ARTICLE III - PURPOSE
