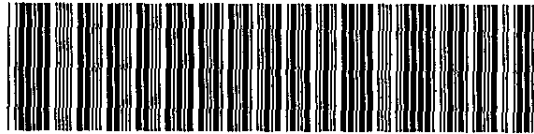

ARTICLE THREE - PURPOSE




